CONDITIONS OF PARTICIPATION (International Pavilion at Cambodia International Gems & Jewelry Fair)

1. **DEFINITIONS**

In these Conditions of Participation and the Application/Contract, save as the context otherwise requires:

"Applicant" means the company named in Section A of the Application/Contract.

"Application" means the application by the Applicant to participate in the International Pavilion at the Exhibition, made by submitting the Application/Contract together with all necessary payments to the World Trade Fair (International) Limited.

'Application/Contract" means the application form to which these conditions are annexed.

"Booth" means a booth in the International Pavilion at the Exhibition which the World Trade Fair (International) Limited licenses the Participant to use for the duration of the Exhibition.

"Conditions" means these Conditions of Participation as amended by the

World Trade Fair (International) Limited from time to time.

"World Trade Fair (International) Limited also means the agent for International pavilion of the Exhibition.

"Exhibition" means the fair or exhibition named in the Application/Contract

"Hong Kong" means the Hong Kong Special Administrative Region of the People's Republic of China.

"International Pavilion" means the pavilion organised by the World Trade Fair (International) Limited to accommodate all participants, which will be built on a specified location assigned by the fair/exhibition organiser;

"Deposit" means an amount equal to 50% of the total payable amount expressed in Section E of the Application/Contract.
"Optional Participation Expenses" means the amount payable by each

Participant for additional facilities and services such as shipment of samples Participant for adoitional facilities and services such as sinjument or samples, extra stand facilities, traveling services and interpreters, provided by the World Trade Fair (International) Limited at its request, which amount shall be determined by the World Trade Fair (International) Limited. "Participant" means the Applicant after its Application has been accepted by the World Trade Fair (International) Limited.

"Participation Fee" means the amount payable by the Participant to the World Trade Fair (International) Limited for the right to participate in the International Pavilion at the Exhibition, as specified in Section E of the Application/Contract.

"Products" means the goods described in Section D of the Application/Contract and which the World Trade Fair (International) Limited agrees to accept for exhibiting at the Booth during the Exhibition.

"Project Manager" means the project manager for the International Pavilion at the Exhibition appointed by the World Trade Fair (International) Limited.

"Publicity Material" means all and any promotional gifts, catalogues, pamphlets, advertising and publicity material whatsoever which the Participant wishes to display, distribute or use at or for the purpose of the Exhibition.

"Related Companies" in respect of the Applicant or Participant means its holding companies, subsidiaries and subsidiaries of its holding companies.

2. ACCEPTANCE

- (a) The Applicant must be a legal business entity with a valid business registration certificate / license with substantial operations in the registered country.
- The Project Manager, on behalf of the World Trade Fair (International) Limited, may in his absolute discretion accept or reject the Application.
- (c) The Applicant represents and warrants that none of its Related Companies, associates, or persons or companies that are effectively under its control has applied to participate in the International Pavilion at the Exhibition. World Trade Fair (International) Limited has an absolute discretion to reject the Application or withdraw its acceptance of the Application if the Applicant shall have breached this warranty and representation.

PAYMENT

- (a) Upon submission of its Application/Contract, the Applicant shall pay to the World Trade Fair (International) Limited such amounts and in such manner as set out in Section 6 of the Application/Contract.

 (b) If the Applicant has requested for additional facilities and services in accordance
- with Section E of the Application/Contract, it shall further pay to the World Trade Fair (International) Limited upon submission of its written request for such services and facilities:
 - such amount as the World Trade Fair (International) Limited considers appropriate as deposit for the Optional Participation Expenses if such request is made prior to the commencement of the Exhibition; and
 - the full amount of the Optional Participation Expenses if such request is made on-the-spot during the Exhibition (see paragraph 3(e) below).
- (c) If the Application is rejected, World Trade Fair (International) Limited will within 30 days of the date of notice of rejection refund to the Applicant all amounts received by it from the Applicant pursuant to paragraphs 3(a) and 3(b) above without interest.

 - if the Project Manager in his absolute discretion decides that such right shall be terminated
- The Participant's right to participate in the International Pavilion at the Exhibition shall automatically terminate in the event that all its Participants are refused entry visa or entry permit to the country or place where the Exhibition shall be held by any competent authorities.

12. EXCLUSION OF LIABILITY
